- introducing the trainees to the concepts and practices used in European Union social security law for overcoming poverty;
- promoting the trainees' recognition of the main provisions in the European Platform against Poverty and Social Exclusion, as well as other socially oriented documents in the European Union;
- broadening the trainees' skills of analyzing the norms of European Union law on overcoming poverty and fighting social exclusion;
- forming the trainees' ability to identify useful European practices in fighting poverty and social exclusion, which can be incorporated into Russian law.

Content

Final discussion in the form of the portfolio project.

What European practices of fighting poverty are relevant for the Russian Federation?

Poverty as a social and economic phenomenon in the Russian context. Level of poverty in the Russian Federation: methods for determining, dynamics, current indicators. Main directions of state policy to combat poverty in the Russian Federation. Measures of social support of the population: system, legal frameworks. Federal, regional and local level of social support. Measures of social support for low-income citizens implemented in the Penza Region and municipal districts of the Penza Region. Social contract: normative regulation and implementation practice in the Penza Region.

Key European practices to combat poverty and social exclusion. Preventive measures: increasing education level of the population, promoting youth employment policy, ensuring equal opportunities and accessible environment for people with disabilities. Measures to reduce poverty: ensuring minimum standard of living for low-income citizens, providing decent housing and good nutrition for women, ensuring employment and social inclusion for the elderly, promoting policy of long-term care for the elderly. Concept of an unconditional basic income and experiments to implement it.

Exchange of views between the target groups (representatives of local and regional authorities, practicing lawyers, economists, social workers, law teachers) on the possibility of effectively using specific European practices to combat poverty and social exclusion in the Russian context.

Assessment

Portfolio project: Based on the knowledge and skills formed during the professional training course, the trainees are invited to present their viewpoints on the best European practices of overcoming poverty and fighting social exclusion in order to improve the legal policy in the Russian Federation.
